The Spirit Mountain Community Fund is the philanthropic arm of the Confederated Tribes of Grand Ronde. Through the Community Fund, the Tribe donates six percent of casino revenue to registered 501c3 nonprofit organizations in northwest Oregon, as well as government agencies in Polk and Yamhill counties, and to the nine federally recognized Tribes of Oregon.

Through Spirit Mountain Community Fund, the Confederated Tribes of Grand Ronde continue to fulfill its native tradition of potlatch, a ceremony at which good fortunes are distributed. We are happy to share the past year's milestones with you in our 2020 Annual Report.

We would like to take this opportunity to recognize and acknowledge all our fearless, creative and determined nonprofit partners, as well as everyone who served on the frontlines during the 2020 pandemic and beyond. We are humbled and grateful beyond measure for your tenacity and resiliency.

Through our responsive grant programs, we provided 96 grants totaling \$2,261,213 to local nonprofit organizations in 2020, bringing our overall giving to \$85,212,837 since the Fund's inception in 1997!

We were also delighted to forge new partnerships in rural and underserved communities during our efforts to prioritize and support those communities disproportionately affected by COVID-19. One common theme and challenge we continue to witness is the ongoing unmet needs and limited access to services for Oregonians living in rural areas.

We are so grateful for her expertise and commitment to serving Oregon's most vulnerable populations. And as we say goodbye to one treasured friend, we welcome another. HATFIELD FELLOWSHIP PROGRAM

The Confederated Tribes of Grand Ronde established the Mark O. Hatfield Fellowship in 1998 as a living tribute to Senator Hatfield to honor his accomplishments as Governor of Oregon and United States. Each year, Spirit Mountain Community Fund sponsors a highly motivated Native American to serve as the Hatfield Fellow and intern in an Oregon congressional office, enhancing the mutual understanding between leadership in Washington, D.C., and Indian Country. Hatfield Fellows begin their Capitol Hill experience in November with a month-long orientation at the American Political Science Association (APSA), followed by an eight-month term in an Oregon congressional office.

2020/21 HATFIELD FELLOW

The Confederated Tribes of Grand Ronde and Spirit Mountain Community Fund are pleased to announce Simone Auger as the 2020/21 Hatfield Fellow. Auger lives in Vancouver, WASH., and is a member of the Confederated Tribes of Grand Ronde.

Auger received a Bachelor of Fine Arts in Interior Design from Marylhurst University and a Master of Interior Architecture from the University of Oregon School of Architecture and Environment. She also holds a Professional Certificate in Tribal Relations from The PSU Institute for Tribal Government, and a Course Certificate from NW Energy Policy and the Columbia River - PSU Mark O. Hatfield School of Government.





SIMONE AUGER

The Hatfield Fellowship usually begins in November with a month-long orientation at the American Political Science Association (APSA) in Washington, D.C., followed by an eight-month office placement, but with COVID-19, this year's fellowship began a little differently than in years past. Auger attended a virtual orientation with APSA and concurrently began working remotely with Congressman Kurt Schrader's office in November.

"I look forward to gaining insight to the inner workings of Congress and the political process, especially where it concerns Tribal affairs," said Auger. "I have a background in utility energy programs where my role included helping Tribes and businesses navigate program resources so they could take control of their energy destiny. With Rep. Schrader serving on the House Committee of Energy and Commerce, I am hoping to utilize my expertise in this area and work on energy policy that serves to enhance Tribal sovereignty through energy independence."

"It is a great honor to have Simone join the Schrader team as this year's Hatfield Fellow. Simone brings a lot of experience working with Oregon Tribes to the Fellowship, which will be a huge benefit to our office. Despite the challenging circumstances due to COVID-19 and the current remote work environment, we are grateful to Simone for her enthusiasm and flexibility, and the Fund's desire to make this a valuable experience," said Congressman Kurt Schrader.

"Last spring, I attended the NCAI Tribal Nations Policy Summit where I heard influential Native women leaders speak, including Deb Haaland, Sharice Davids and Fawn Sharp. This was a pivotal moment and a big inspiration for me," said Auger. "I feel so fortunate for the opportunity to serve as a Hatfield Fellow, and I greatly admire the accomplishments of past Fellows who have made incredible contributions in their chosen careers. I am committed to using this time to further my education and hone my leadership skills so I can give back and serve as an example for future Fellows."

Prior to completing her fellowship in July 2021, Auger was offered a permanent position as a Legislative Assistant in Congressman Schrader's office.

"I continue to be so inspired by our Hatfield Fellows, who are determined to be strong ambassadors in their communities with lasting benefits to all the Oregon Tribes," said Michael Cherry, Executive Director. "I lift my hands to the Grand Ronde Tribal leaders who created the Hatfield Fellowship in 1998, and also to the 21 Hatfield Fellows, to date, who make us all so proud. Simone is a perfect example of why our leaders created this program and we're all so very proud of her accomplishments."

Each award recipient receives a special plaque, a free night stay and dinner for two at Spirit Mountain Casino, and a check in the amount of \$500 for their outstanding contributions to the nonprofit sector.

VOLUNTEER AWARD

David Solomon - Volunteer at American Legion Post 10

David's nomination letter:

We, the members of American Legion Post 10 Albany, Oregon in Linn County, are pleased to nominate our Commander, David Solomon, for the 2020 Ye?lan Lima Award. Commander Solomon, an unpaid volunteer, puts in numerous hours each day in the daily operation of American Legion Post 10. Commander Solomon is a retired NYFD EMS employee who was one of the first responders at 9/11.

In spite of his injuries and health issues stemming from working "the pile," David continues to give of himself in remarkable ways. Through his compassionate and supportive leadership, Post 10 has distinguished itself as one of the largest and the most active Posts in this state. Through his efforts, the Post receives funds and donated new toys to help underprivileged children in our area receive a nice Christmas. Each year the

Commander dresses up as Santa and spends hours talkina

to the children who come to sit on his lap and share their most cherished Christmas wishes with him. In the past, the Post has served up to 1,250 children.

During COVID and the summer wildfires, David's leadership helped our community. He opened up to the Post for anyone displaced by the wildfires and helped feed them through the Veterans Food Pantry he established last spring. He also teaches first aid/CPR to the community.

We at Post 10 consider ourselves fortunate to have such a person at the helm and highly recommend him for the Ye?lan Lima Award.

PAID STAFF AWARD

Robin Gardner - Volunteer Coordinator for CASA of Linn County

Robin's nomination letter:

Robin first joined as a volunteer Court Appointed Special Advocate (CASA) eleven years ago with the mission to advocate for the best interests of children in foster care. In 2016, she became a paid Volunteer Coordinator who supports over 25 volunteer advocates while continuing to volunteer as an advocate outside her normal work hours.

At that time, she promised her family that she would retire by 2020. Once 2020 came, the Executive Director at the time resigned and COVID-19 shut the office down. Therefore, Robin displayed immense dedication and commitment to her volunteers and the children they serve by staying on with CASA until the end of the year to train new staff who have come onboard.

Due to the COVID-19 pandemic, Robin

provided our first ever Virtual Training via Zoom with new advocates that led to eight new volunteers. Never once did she complain about not being able to do a training in-person and her flexibility allowed us to assign 12 children in foster care to a new advocate.

In conclusion, I am honored to work alongside Robin as she continues to give her "all" every day with compassion and respect to support our volunteer advocates and the children they serve when she had every opportunity to retire at the beginning of year due to the chaos from COVID-19.

PAID MANAGEMENT AWARD

Barb Farmer - Clinical Manager at Willamette Valley Hospice

Barb's nomination letter:

Barb Farmer has been a clinical manager at Willamette Valley Hospice since 2013. With 30 years of experience, Barb is also a known hospice expert.

During the COVID-19 pandemic, Barb immediately was ready to implement safety measures to protect patients, families and staff. She assists with testing staff for COVID-19 so that we can safely provide care at facilities. Barb has a true passion to make certain every patient and family, regardless of their ability to pay, will receive high-quality care. But her passion doesn't end there. She is passionate about making sure

every employee is valued and heard.

During this very

challenging time, she saw employee fatigue as we were taking care of patients dying of COVID-19 and purchased a massage chair for staff use when they come to the office. During the area fires, Barb personally called all staff who potentially could be impacted. Throughout the evacuations of patients and some staff, Barb facilitated the coordination of patient care, even in their temporary locations.
